

Terms and Conditions of Use

1. General and Acceptance

1.1

Below are the Terms and Conditions of Use, hereinafter referred to as "Terms and Conditions of Use," which will apply to the use of the Website bigshopcenter.com, www.bigshopcenter.com, or www.bigshopcenter.com.ar, hereinafter referred to as the "Site" or "Big Shop Center," by any individual and/or legal entity who for any reason accesses and/or uses the Site, hereinafter referred to as "User" and/or "Users" interchangeably. Acceptance of these Terms and Conditions of Use constitutes a valid and enforceable contract, which will remain in force until its termination under the conditions established herein.

The Personal Data Privacy Policy, hereinafter referred to as the "Privacy Policy," available at www.bigshopcenter.com, is an integral part of these Terms and Conditions of Use.

If the User interacts with and/or merely uses the Site in any way or creates a User Account, it will be understood that they have fully and unreservedly accepted these Terms and Conditions of Use and the Privacy Policy, which are mandatory and binding for all Users. Consequently, the User undertakes to comply with all the provisions contained in these Terms and Conditions of Use, under the applicable laws, rules, regulations, and regulations applicable to the use of the Site, and also undertakes to respect and comply with all supplementary conditions informed by Big Shop Center or stated on the Site.

IF THE USER DOES NOT ACCEPT THE TERMS AND CONDITIONS OF USE, THEY MUST REFRAIN FROM ENTERING AND/OR USING THE SITE IN ANY WAY, AND IF THEY USE IT, IT IS UNDERSTOOD THAT THEY HAVE ACCEPTED THEM.

1.2. Validity

These Terms and Conditions of Use will come into force from the moment the User accesses and/or uses the Site, according to what is established herein, and will remain in force with all the updates made to it, during the entire duration of the relationship between the User and Big Shop Center.

1.3. Modifications

Big Shop Center reserves the right, at its sole discretion and at any time, to modify or replace any of these Terms and Conditions of Use by making them public on the Site without prior notice. Continued use of the Site after the publication of any changes to these Terms and Conditions of Use constitutes the User's express and unreserved acceptance of such modifications. Therefore, the User agrees to review these Terms and Conditions of Use whenever they use the Site in any possible way.

1.4. Capacity

The use of the Site may only be carried out by those who have the legal capacity to contract, as established in the applicable legislation. A person who does not have such capacity may not use the Site. If a natural person uses the Site on behalf of a legal entity, that natural person who proceeds with such registration declares by that act to be

authorized to exercise the legal representation of said legal entity and therefore to bind it in accordance with the terms of these Terms and Conditions of Use.

2. Use of the Site

2.1. Use of the Site and Scope of the Service

The Site is available to Users so that they can virtually access the products and services promoted by companies and/or individuals, hereinafter referred to as "advertisers" or "advertising companies," with whom we are affiliated, exclusively navigating on www.bigshopcenter.com and/or www.bigshopcenter.com.ar. It is understood that this site is not a product or service sales site but a promotion site for advertisers' products and services, which have authorized the site to advertise them. The entire purchase process, regret button, payment, delivery, and warranty of the product or service are the responsibility of the user and the advertised companies. The User undertakes to use the Site in accordance with the law, these Terms and Conditions of Use, as well as generally accepted morals and good customs, the applicable legislation, and public order. The User undertakes to refrain from using the Site for illegal purposes or effects, contrary to what is established in these Terms and Conditions of Use, harmful to the rights and interests of third parties, or that in any way may damage, disable, overload, or deteriorate the Site or prevent its normal use by other Users.

2.2. User Account

To browse the site, no user account is required. To purchase promoted products on the sites of the advertised companies, the User must obtain an account on the respective sites. To this end, they must register and obtain a personal User Account in accordance with the terms and conditions of the advertising companies, hereinafter referred to as "User Account," providing their full name (first and last name) and email address, and creating a password for this User Account and other data that the advertising companies determine.

2.3. "I want it" Button through the Site

The User can browse the Site for the products or services they wish to purchase without having a User Account. Once the product or service is selected, if the User wishes to buy it, they can press the "I WANT IT" button or a similar button detailed on the site. It is understood that pressing the mentioned button does not yet constitute a purchase but is a voluntary action by the buyer to redirect to the official website of the advertising companies that sell the products or services and are responsible for their delivery, possibly going through other intermediary websites determined by the advertising companies. Big Shop Center does not participate or intervene in the purchase process, so the user expressly waives any claims against Big Shop Center for any reason or cause related to the purchase of the product or service promoted on the site.

2.3.1. Product Publications.

The User should note that the images included on the Site are illustrative, and the technical specifications and descriptions are as accurate as possible and subject to changes due to inadvertent errors or inaccuracies without prior notice. The technical characteristics of the purchased products or services and the published price may vary since the final price depends on the one published on the promoted advertising companies' website and the fluctuation of the relevant currency.

2.3.2. Availability.

The sale of any products or services published on the Site is subject to the availability of stock by the promoted advertising companies, approval of the User's identity, and correct credit or debit card or other payment method imputation permitted by the Site. Any purchase made by the User on the sites of the promoted advertising companies implies the express approval of these Terms and Conditions of Use and those of the promoted advertising companies. Note that due to technical and update issues on the Site, a product may show as available but then be unavailable due to stock issues or other reasons on the promoted advertising companies' website.

2.3.3. Product Prices.

The prices of the products published on the Site may not match those offered on the promoted advertising companies' websites due to the aforementioned reasons. Any announced promotion must be contracted on the advertising companies' website, and in such a case, the user must make any claims regarding the product or service purchased there.

2.3.4. Operation.

To carry out the Operation, the User must enter the personal data requested by the promoted advertising companies' website for billing purposes, which must match the cardholder's data used for the transaction. The User may select the delivery methods informed by the advertising companies according to the options they inform, such as a) Pickup at Branch, b) Home Delivery, c) Digital Download, or any other. Note that delivery methods and costs will depend on the number of products purchased by the User and the place of delivery, not included in the product or service price. Delivery costs will be added to the same invoice for the product or service purchased from the promoted advertising companies.

2.4.1. Big Shop Center Market:

Big Shop Center displays its Site in the form of a Marketplace for advertising companies unrelated to Big Shop Center to offer their products and services. All products on the Site belong to third-party offers, such as the promoted advertising companies' products and services. The User expressly accepts that these are subject to the special dispatch and delivery conditions found on each of the promoted advertising companies' websites. The User understands and accepts that the conditions may vary from those established in these Terms and Conditions of Use. The User declares and undertakes - before completing any operation - to carefully read and accept the specific conditions of the operation according to the promoted advertising company's site corresponding to the product or service. The User acknowledges and accepts that in any case, Big Shop Center is not part of any operation and has no control over the quality, safety, or legality of the advertised goods and services, the truthfulness or accuracy of the publications, the third parties' ability to sell products or services, nor over their delivery or deadlines or guarantees.

2.4.2. Returns and Exchanges:

In these cases, the user must make the return, exchange, or regret purchase of products or services directly on the promoted advertising companies' website where the product was purchased, following the instructions established by each company or website. Big

Shop Center does not intervene in these operations. It is hereby stated that the User is informed that according to Argentine legislation, they have the right to revoke the offer acceptance on the respective sales sites within ten (10) calendar days from the delivery of the product or from the contract's celebration, whichever occurs last, under the terms of the current regulations with the company where the product or service was purchased.

2.4.3. Prohibited Acts

The User may not: a) Use the Site to perform acts contrary to the law, morals, public order, these Terms and Conditions of Use; b) Introduce or spread data programs (viruses and harmful software) that may cause damage to the Site's computer systems or the access provider, its suppliers, or third-party Internet users; c) Use the Site to carry out illegal activities or acts constituting an offense; d) Reproduce, duplicate, sell, market, or exploit in any way the content of the Site; e) Upload, post, email, or otherwise transmit any content that is illegal, harmful, threatening, abusive, harassing, defamatory, vulgar, obscene, invasive of another's privacy, hateful, or racially, ethnically, or otherwise objectionable; f) Attempt to obtain unauthorized access to the Site or its connected systems or networks.

Legal Notices

3.1. Third-Party Sites

The Site may be accessed from or contain links to third-party websites, which are neither owned nor operated by Big Shop Center, nor are they related to it. Since Big Shop Center has no control over such sites, it is not and will not be responsible for the contents, and/or products and/or services provided by them, nor for any damages and/or losses caused to Users by their use. Access to the Site through third-party sites or the presence of links to other websites or references to names, brands, links, or services of third parties does not imply that they have been monitored, recommended, reviewed, or approved by Big Shop Center, nor that there is any relationship with the owners of such sites or brands. Therefore, the use of these sites by Users will be at their sole responsibility, choice, and consent. The User understands and agrees that if they were referred from a third-party site to Big Shop Center, any management related to the purchased product must be carried out directly with the third-party responsible for the referring site. The User acknowledges that Big Shop Center has no obligation to accept discounts, coupons, vouchers, and/or any other incentives that the User may have obtained and/or acquired from third parties outside the Website. It is informed that Big Shop Center is not the owner of the trademarks of the advertising companies whose products or services are promoted on the site, but rather the trademarks are the property and exclusivity of each of those companies or those advertising companies and sites. As an Amazon.com associate or other advertising companies, Big Shop Center earns commissions through affiliate programs on qualified purchases made by users on the advertising companies, being redirected from Big Shop Center with some promoted product or service, to the advertising companies' websites. Neither we nor any of our affiliates or licensors make any representations or warranties of any kind, whether express, implied, statutory, or otherwise, regarding the service offerings.

3.2. Site Content

The content of the Site made available to the User, such as text, graphics, images, logos, and any other material, is protected by intellectual property laws and is the exclusive property of Big Shop Center or its suppliers or other third parties or promoted companies. Its use and/or reproduction is prohibited without the express authorization of Big Shop

Center and/or in the case of the owners of each of the logos and/or trademarks. The site is not responsible for possible service outages of the server where it is hosted, or for any other issue or event that prevents the site from being online for navigation, and users waive any claim for such matters.

3.3. Termination

The User agrees that Big Shop Center, at its sole discretion, may terminate, suspend, cancel, or interrupt unilaterally, at any time and without prior notice or justification, the User's ability to use the Site, or that the website for any reason is not available, whether temporarily or permanently, without any of these circumstances giving rise to any compensation, claim of any nature based on the termination of the agreement or liability of Big Shop Center.

3.4. Indemnity

The Site may only be used for lawful purposes, and the User is entirely responsible for the use of the Site, being expressly obliged to hold Big Shop Center harmless from any claim, extrajudicial, administrative, or judicial, from third parties, related to the inappropriate use of the Site or in contravention or violation of any of the stipulations of these Terms and Conditions of Use. The User is aware and accepts that the lack of measures and/or actions taken by Big Shop Center related to a breach and/or violation by the User of these Terms and Conditions of Use cannot be interpreted as an acceptance and/or waiver of the rights and actions that may correspond to Big Shop Center for such breach or violation.

3.5. Integrity

The headings used in these Terms and Conditions of Use are for reference purposes only and in no way define or limit the scope of the provision they title. If any part of these Terms and Conditions of Use is declared invalid by any authority, the rest of its parts will remain fully valid and effective. In all cases where possible, Big Shop Center reserves the right to integrate and interpret the parts not declared invalid by such authority.

3.6. Jurisdiction and Applicable Law

The Big Shop Center Site (trade name) is owned and managed by its owner C. J. N. with its e-commerce activity domiciled in the province of Buenos Aires, Argentina. These Terms and Conditions of Use are governed by the current legislation of the Argentine Republic, and the Parties submit to the jurisdiction of the Ordinary Civil and Commercial Courts of the province of Buenos Aires or the Capital Federal, Argentina, as the case may be, waiving any other jurisdiction that may correspond to them.

3.7. Notifications

Unless otherwise indicated, notifications to Big Shop Center must be sent to Argentina, and for any questions the User may have related to these Terms and Conditions of Use, they can do so by contacting the Big Shop Center Customer Service Center at contactbigshopcenter@gmail.com, on the days and hours indicated at the bottom of the Site on its main page. Unless expressly stipulated otherwise, any notification to Users related to these Terms and Conditions of Use will be made through publications on the Site, having full validity from the moment of their publication.
